Dear Ambassador Khazaee:

According to reports coming out of Iran, Iranian officials have now leveled charges of rape and extortion¹ against 32-year-old Youcef Nadarkhani, the Christian Iranian pastor who was sentenced to death on charges of apostasy². That these highly suspect charges, which were not referenced in any way during Nadarkhani's 2010 apostasy trial before the Iranian Supreme Court, have only now emerged reflects poorly on the integrity of the justice system in Iran.

Should Iran, one of the world's oldest civilizations, ever truly hope to take its place as a world leader alongside other developed nations, it must begin by prioritizing

² Youcef was convicted of apostasy after protesting his government's decision to teach Christian schoolchildren—including his 8- and 6-year-old sons—about Islam. Over the course of the past two years Youcef has spent in prison, he has suffered various forms of irregular punishment, including a denial of access to his attorney, the arrest of his wife, threats to place his two sons in the custody of Muslim families, and the administration of drugs in an attempt to force him to recant his religious faith.

To this end, releasing Nadarkhani and dropping the charges against him would send a strong message, not only to other Islamic nations but to all nations, that Iran's strength lies in its ability to traverse the moral high ground.

We⁴ urge you to do all within your power to urge the government leaders and the people of the Islamic Republic of Iran to be vehicles of mercy and peace, in keeping with the true mandate of the prophet Mohammad.
